

BNZ BREAKERS – CHRISTCHURCH PRIZE DRAW

TERMS AND CONDITIONS

1. Promoter

The promoter is **NZ Breakers Club Limited** ("Promoter"), 7 Atlas Place, Rosedale, Auckland 0632, New Zealand.

2. Promotion Overview & Key Dates

- **Eligible Game:** BNZ Breakers vs Adelaide 36ers, **Thursday, 6 November 2025**, 7:30pm, Wolfbrook Arena, Christchurch.
- **How to Enter:** Purchase at least one eligible ticket to the above game **by 5:00pm, Thursday, 6 November 2025** ("Purchase Deadline") and you will be entered into the prize draw(s) described below.
- **Draw Times:**
 - **Exclusive Shoot-Around Draw: 5:00pm, Monday, 3 November 2025.**
 - **Major Prize Draw & Epic Prizes Draw: 5:00pm, Thursday, 6 November 2025.**

3. Eligibility

- Open to **New Zealand residents** aged **18+**. If a winner nominates a guest who is a minor, the guest must be accompanied by their parent/guardian.
- Employees, officers and directors of the Promoter and its agencies, and their immediate families, are ineligible.
- The Promotion is void where prohibited by law.

4. Entry Mechanics

- One (1) entry is awarded **per eligible ticket order/transaction** completed by the Purchase Deadline for the Eligible Game (multiple tickets in one order = one entry).
- Resale, cancelled, refunded or fraudulent transactions are ineligible and may be voided at the Promoter's discretion.
- The Promoter may request proof of purchase and identity to verify eligibility.

5. Prizes

A. Major Prize – The Ultimate BNZ Breakers Weekend (Auckland, 2026):

- Return economy flights for two (2) **Christchurch ↔ Auckland** (same itinerary).
- Two (2) nights' twin/double accommodation at **Rydges Hotel Auckland** (standard room, room-only, hotel's terms apply).

- Two (2) **Premier Courtside Seats** to the BNZ Breakers home game on **Saturday, 7 February 2026** at Spark Arena (or comparable category if unavailable).
- **SIXT** premium rental car for the weekend (standard rental terms apply, incl. valid full driver's licence, minimum age requirements, bond/deposit, fuel, insurance excesses/fees).
- **Travel Conditions:** Winner and guest must travel on the dates specified by the Promoter; changes are not permitted. All incidental costs (meals, transfers, parking, insurance, excess/bonds, upgrades, additional drivers, mini-bar, etc.) are the winner's responsibility.

B. Epic Prizes (Drawn 6 November 2025):

C. Exclusive Shoot-Around Access (Drawn 3 November 2025):

- Winners receive access to a BNZ Breakers team shoot-around session linked to the Eligible Game (date/time and venue as advised; subject to team/venue operations).
- Access is observational and non-participatory unless otherwise specified by the Promoter.

General Prize Notes:

- Prize details (brands, models, seat locations, room types) may vary and are subject to availability.
- **No cash alternative**, substitutions or transfers, except the Promoter may substitute a prize (or component) with one of equal or greater value if reasonably required.
- Vouchers are subject to each issuer's terms, conditions and expiry dates.

6. Winner Selection & Notification

- Random electronic draws will be conducted at the times in Section 2.
- **Major Prize winner** will be **announced at the game on 6 November 2025** (and also notified by email/SMS if details are held).
- **Epic Prize winners** will be **notified by email within 48 hours** of the draw.
- **Shoot-Around winners** will be notified by email after the 3 November draw.
- If a winner cannot be contacted, fails to respond within **48 hours**, or is found ineligible, the Promoter may conduct a **redraw**.

7. Courtside Seating – Eligibility & Conduct (Upgrades & Major Prize Seats)

- Courtside seating/upgrade is valid **only** for the BNZ Breakers home game and date specified by the Promoter.
- **Valid game tickets are required for entry**; upgrades do **not** include entry tickets. Courtside access requires presentation of both the valid game ticket and the courtside entitlement.
- Guests must arrive **at least 30 minutes before tip-off** for check-in.
- **Code of Conduct:** Guests must comply with BNZ Breakers and venue policies and all staff instructions. Remain seated during live play. Disruptive or unsafe behaviour may result in removal **without refund or replacement**.

8. Health, Safety & Operational Changes

- All guests must follow current venue **health and safety** protocols.
- The Promoter may modify, postpone or cancel any experience (including courtside or shoot-around access) due to unforeseen circumstances such as team operations, venue requirements, health advisories or safety concerns. Reasonable alternatives will be considered where feasible; otherwise no compensation is payable.

9. Liability

- To the maximum extent permitted by law, the Promoter and the host stadium are **not liable** for any personal injury, loss or damage to property arising from participation in the Promotion or any prize use. Participation and attendance are **at the guest's own risk**.
- Nothing in these T&Cs limits rights under the **Consumer Guarantees Act 1993**.

10. Privacy

- Personal information is collected to administer the Promotion and award prizes. It will be handled in accordance with the Promoter's privacy policy and may be shared with service providers solely for Promotion administration. Entrants may request access to, and correction of, their personal information.

11. General

- The Promoter's decisions are **final** and no correspondence will be entered into.
- The Promoter may disqualify entries that are incomplete, fraudulent, or do not comply with these T&Cs.
- If the Eligible Game is postponed or cancelled, the draws may be rescheduled or prizes adjusted at the Promoter's reasonable discretion.
- These T&Cs are governed by the laws of New Zealand.
